

## INTERNATIONAL WORKSHOP ON COMPUTATIONAL NANOTECHNOLOGY

The International Workshop on Computational Nanotechnology is a forum for research on the development and application of advanced simulations of nanostructures, nanomaterials and nanodevices. Conference delegates include academic and industrial researchers who are either developing in-house simulation tools; demonstrating novel applications of commercial or public-domain tools; or combining and customising tools to address specific application challenges. The conference attracts a wide range of researcher seniority, from research students to international research leaders.

Topics include electronic structure calculations; simulations of electronic, optical and mechanical properties of nanostructures; simulations of electronic, thermal, spin and molecular transport processes; multiscale and multiphysics simulations; computational design and evaluation of engineered nanomaterials and nanostructures; simulation of nanodevice processing and performance.
